4. All candidates shall be available in the institute during the working hours.

6. The salary is consolidated as mentioned in the notification and no other facilities will be provided by the institute.
7. Any additional responsibilities can be assigned at any time for smooth functioning of the Institute.
8. While reporting all candidates shall submit original documents for verification.
